**THE VIT UNIVERSITY, JAIPUR (CHANGE OF NAME)
ACT, 2013**

(Act No. 25 of 2013)

[Received the assent of the Governor on the 15th day of September, 2013]

to change the name of the VIT University, Jaipur and to make certain amendments in the VIT University, Jaipur Act, 2012.

Be it enacted by the Rajasthan State Legislature in the Sixty-fourth Year of the Republic of India, as follows:-

1. Short title and commencement.- (1) This Act may be called the VIT University, Jaipur (Change of Name) Act, 2013.

(2) It shall be deemed to have come into force on and from 7th June, 2013.

2. Change of name of the VIT University, Jaipur.- (1) The name of the VIT University, Jaipur incorporated under the VIT University, Jaipur Act, 2012 (Act No. 11 of 2012), hereinafter referred to as the principal Act, shall, as from the date of commencement of this Act, be "The Vivekananda Global University, Jaipur".

(2) Any reference to the VIT University, Jaipur in any law for the time being in force or in any indenture, instrument, or other documents shall be read and construed as a reference to that University under its name as altered by this Act.

(3) Nothing in this Act shall affect the continuity of the corporate status of the said University.

3. Amendment.- (1) As from the date of commencement of this Act, the principal Act shall stand amended to the extent and in the manner specified in the schedule.

(2) The provisions of sub-section (1) shall be without prejudice to the generality of the provisions of section 2.

4. Citation of the principal Act.- The principal Act may be cited as the Vivekananda Global University, Jaipur Act, 2012.

5. Repeal and savings.- (1) The VIT University, Jaipur (Change of Name) Ordinance, 2013 (Ordinance No. 8 of 2013) is hereby repealed.

(2) Notwithstanding such repeal, all things done, actions taken or orders made under the principal Act as amended by the said Ordinance shall be deemed to have been done, taken or made under the principal Act as amended by this Act.

THE SCHEDULE

(See section 3)

Preamble.- In preamble, for the existing expression "*the VIT University, Jaipur*", the expression "*the Vivekananda Global University, Jaipur*" shall be substituted.

Section 1.- In sub-section (1), for the existing expression "the VIT University, Jaipur Act", the expression "the Vivekananda Global University, Jaipur Act" shall be substituted.

Section 2.- For clause (za), the following clause shall be substituted, namely:-

"(za) "University" means the Vivekananda Global University, Jaipur."

Section 3.- In sub-section (1), for the existing expression "the VIT University, Jaipur", the expression "the Vivekananda Global University, Jaipur" shall be substituted.

THE VIT UNIVERSITY, JAIPUR ACT, 2012

(Act No. 11 of 2012)

[Received the assent of the Governor on the 30th day of April, 2012]

to provide for establishment and incorporation of the VIT University, Jaipur in the State of Rajasthan and matters connected therewith and incidental thereto.

Whereas, with a view to keep pace with the rapid development in all spheres of knowledge in the world and the country, it is essential to create world level modern research and study facilities in the State to provide state of the art educational facilities to the youth at their door steps so that they can make out of them human resources compatible to liberalized economic and social order of the world;

And whereas, rapid advancement in knowledge and changing requirements of human resources makes it essential that a resourceful and quick and responsive system of educational research and development be created which can work with entrepreneurial zeal under an essential regulatory set up and such a system can be created by allowing the private institutions engaged

Body shall, immediately after the commencement of this Act, take steps for such vesting.

(3) The University shall have perpetual succession and a common seal and shall sue and be sued by the said name.

(4) The University shall situate and have its headquarters at Village Sisyawas and Dantli, Tehsil Sanganer, District Jaipur (Rajasthan).

4. The objects of the University.- The objects of the University shall be to undertake research and studies in the disciplines specified in Schedule II and such other disciplines as the University may with the prior approval of the State Government, determine from time to time and to achieve excellence and impart and disseminate knowledge in the said disciplines.

5. Powers and functions of the University.- The University shall have the following powers and functions, namely:-

- (a) to provide for instruction in the disciplines specified in Schedule II and to make provisions for research and for the advancement and dissemination of knowledge;
- (b) to grant, subject to such conditions as the University may determine, diplomas or certificates, and confer degrees or other academic distinctions on the basis of examinations, evaluation or any other method of testing on persons, and to withdraw any such diplomas, certificates, degrees or other academic distinctions for good and sufficient cause;
- (c) to organize and to undertake extra-mural studies and extension service;
- (d) to confer honorary degrees or other distinctions in the manner prescribed;
- (e) to provide instruction, including correspondence and such other courses, as it may determine;
- (f) to institute Professorships, Associate Professorships, Assistant Professorships and other teaching or

(b) Offering of programs in Online and ODL Mode

The Academic Council at its 21st meeting held on 6th October, 2022 had approved offering of Online and Distance Learning programmes by the university. Presently, as approved by the Academic Council, VGU is offering BA, BBA, BCA, MA (English), MBA, MCA and M. Sc. (Mathematics) programmes in Online Mode.

Now the university proposes to offer Master of Arts in Journalism and Mass Communication (MAJMC) programme in Online Learning mode from the academic session 2024-25.

Besides, the VGU is also offering BBA, BCA, MBA, MCA and M. Sc (Mathematics) programmes in ODL mode since Jan, 2024. The University now proposes to offer BA (any three subjects: - Economics, Political Science, Public Policy and Development, International Relations, Psychology, English, History, Computer Applications) and MA (English) programmes in Open and Distance Learning mode from the session 2024-25.

The Self Learning Material (SLM), Syllabus and Programme Project Report (PPR) of the above programmes is placed on the table for consideration and approval of the Board.

Council members considered and approved offering of above-mentioned programmes from the session 2024-25 and authorized Director, CDOE to file required documents to DEB.
