The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The final observations of the Executive Committee are mentioned below for your information and compliance:

- Institution must recruit 2 Assistant Professors before the commencement of academic session.
- All core faculty must be ratified by the Council's nominee.
- The area of the studio should be brought at par with COA norms.

The institution shall initiate necessary remedial actions, if any, based on the observations of the Executive Committee & Inspection Committee and send its compliance/observations on the same for further consideration. The Council shall be at liberty to inspect the Institution at any point of time to verify the compliance made by the institution and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time.
